Request

You asked us:

"I submitted an FOI request in November last year, requesting disclosure of the equality impact assessment (which you appear to be calling 'PEIA') relating to the ICO's framework to prioritize FOI complaints.

The response I received at the time (case reference IC-202740-X3C7) was that a 'PEIA' had not been conducted yet because the framework was still under consultation.

It appears that, following the consultation, the ICO is now going ahead with its plans (<u>ICO to prioritise Freedom of Information complaints with significant public interest | ICO</u>) and that you started implementing the approach from April this year.

Therefore, as the approach is now live, can I please request disclosure under FOIA of the equality impact assessment (or 'PEIA' to use ICO terminology) the ICO conducted in relation to the FOI prioritization framework to assess the equality impact on protected characteristics of its new approach?"

We received your request on 20 June 2023. We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

You have requested a copy of the EQIA we conducted for the FOI prioritisation process. I can confirm that we did not conduct an EQIA for the FOI prioritisation process and therefore no information is held.

For further context, we did not deem it necessary to complete an EQIA because the consultation provided us with valuable feedback which allowed us to make



changes to the prioritisation criteria – in particular the requester based criteria. Further, there was no intention to treat the handling of any cases differently, with the exception that some might received prioritised allocation. The FOI prioritisation framework is part of the Better FOI project, and it is being continually reviewed to ensure it functions appropriately and remains fit for purpose.
